RICHMOND CHAPTER OF CREDIT UNION'S SCHOLARSHIP

Two (2) \$1500.00 scholarships are available for college, technical, or trade school enrollment after June 30, 2012 and before December 31, 2012.

The scholarship is available to a high school student who will graduate in 2012 and will begin college by 12/31/2012.

The applicant must be a member or their parent(s) must be a member of a Richmond Chapter Credit Union.

The scholarship will be awarded primarily on the basis of merit, not financial need.

The applicant must have a minimum cumulative grade point average (GPA) of 2.8 (grades 9-11). **An official transcript must accompany each application.**

The applicant must have demonstrated leadership skills and a strong involvement in extracurricular activities and community service organizations.

The applicant shall have demonstrated outstanding citizenship qualities that show loyalty, trustworthiness, integrity, and a genuine concern for the well being of others.

The applicant **MUST** complete the attached application, including a written essay of 300 to 500 words explaining the "Credit Union Difference" and what it means to the applicant.

The application, including the essay and official transcript, must be returned to the scholarship committee by Wednesday, March 28, 2012 at the following address:
